


Fig. 1.1. Map of Meldrum, Bourtie and Daviot Community Council Area

#### 1: BACKGROUND

Meldrum, Bourtie and Daviot Community Council Area covers three historic parishes NW of Aberdeen. Meldrum, more formally Oldmeldrum, is a small town, Bourtie a tiny hamlet and Daviot a small village.

Meldrum population 3,304 (2016 est.) is a modern town in appearance due to housing expansion to cater for a 60% rise in population between 2001 and 2011. Its population is relatively young, prosperous, and mainly employed outside the town: largely in Aberdeen. However, its historical centre around the Square with old buildings and narrow winding streets remains. Located on two ancient drove roads, Meldrum has a long history, dating back to before the Battle of Barra in 1308. In 1672 a Charter as a Burgh of Barony enabled it to hold a weekly market. Morris's Hotel, the oldest building in the town was established at this time. In 1684, the parish church was moved from Bethelnie into the town. Oldmeldrum became the main market centre of the medieval lordship of Garioch until it was supplanted by Inverurie in the 19<sup>th</sup> Century.

**Daviot** is a small village with a primary school, a brand-new Village Hall, several businesses, a church (1798), and a mixture of cottages and small individual modern housing. The House of Daviot, the Aberdeen Royal Mental Hospital in the 19<sup>th</sup> Century, has been re-developed into large modern apartments with additional new houses. In 2009, **Daviot Community Trust** took 22 acres of its grounds into community ownership. Its volunteers "have created an extensive path network, which received a Paths for All national award, and planted over 600 trees."



Bourtie church, rebuilt in 1806, lies in the centre of its parish. There is no village. Settlement is sparse and scattered throughout the parish.

#### **HISTORY**

The Battle of Barra, 23rd May 1308, affects contemporary Meldrum, for in 2011, the battle site was included in the Inventory of Scotland's most important historic battlefields. Therefore it is a material consideration in the planning process and must be taken into account when deciding planning applications. Its boundary includes much of Meldrum's western suburbs.

**Barra castle** has a complex history but dates at least to the 15th Century. It was restored to its present appearance in 1910/11.

**Barra hillfort.** This "well-preserved monument", on the summit of the 193m Hill of Barra, "is an excellent example of a multi-vallate hillfort, probably Iron Age, with almost complete circuits of all three ramparts visible on the ground."

**Loanhead of Daviot Recumbent Stone Circle** is one of the best examples of this type of monument found only in north-east Scotland. However, this projection of Loanhead as the "archetypal" recumbent stone circle is partly the product of heavy restoration in 1934–5.

**Kirkton of Bourtie Recumbent stone circle**, just outside the hamlet of Kirkton of Bourtie, is badly damaged. The recumbent, though broken is the longest of all known recumbents.

**Sheldon Stone Circle** located nearby may not be a recumbent circle for there is no obvious recumbent stone and the uprights are not height graded.

# 2: OLDMELDRUM, DAVIOT AND THE ABERDEENSHIRE LOCAL DEVELOPMENT PLAN (LDP) 2017

A Local Development Plan (LDP) is map-based concisely linking Council Planning policies/proposals to locations. It is regularly updated. The current Aberdeenshire LDP was adopted in April 2017. Its successor, LDP 2021, is already well advanced.

LDP 2017 follows the *Aberdeen City and Shire Strategic Development Plan 2014*, identifying two broad policy areas:

- a) Strategic Growth Areas, absorbing 75% of anticipated growth, follow main transport routes out of Aberdeen: A90 to Peterhead; A96 to Huntly; and A90 to Laurencekirk;
- b) Local growth and diversification areas, where growth will be matched to local needs, are further divided into a more accessible or pressured area adjacent to the city and a less accessible area further out.

Oldmeldrum is located in the *pressured area* where local needs are viewed as requiring more restrictive planning policies. Allocations to meet these pressures are often limited by available infrastructure. Daviot, like many such settlements, is designated for small-scale organic growth to meet specific needs, e.g. sustaining the school roll, retaining facilities, or local employment.

In addition, the LDP permits development in the countryside if it is refurbishment or replacement of an existing or disused building; on a previously developed site now redundant; or a dwelling house associated with the retirement succession of a viable farm holding.

#### **OLDMELDRUM**

# Vision

Oldmeldrum is a key settlement located in mid-Formartine characterised by its former role as a market town and providing services to surrounding communities, including secondary and primary schools, shops, healthcare and community facilities. The Victorian market square and a location overlooking the surrounding agricultural land are central to the settlement's sense of place.

Key planning objectives will be to protect and enhance the settlement as a service centre, provide new job opportunities, and improve community facilities. With its services, central location in Formartine, and good transport links, meeting the demand for new homes is also a key planning objective.

These objectives will be met through the existing OP1, OP2, OP3 and Business allocations.


# Natural and Historic Environment

# **Allocated Sites**

OP1: Land north of Distillery Road

Allocation: 50 homes, including 12 affordable, and community facilities

This site will require a masterplan; two access points; Safe, convenient and attractive public access to the community facilities on site; Active travel linkages into and within the development and Links to the existing adopted core path to the west of the site; buildings' design should respect surrounding local architectural styles as the site borders the Oldmeldrum conservation area.

**OP2:** West of Coutens Park

Allocation: 50 homes, including 12 affordable, and 4.2ha of employment land

This site will require a masterplan; two access points; homes' design to be sympathetic to surrounding properties reflecting traditional Aberdeenshire architectural styles. Given the prominent location overlooking Oldmeldrum, care must be taken to reduce visual impact.

**OP3:** Land South of Millburn Road

Allocation: 40 homes (under construction)

Future development of this site should ensure connectivity with housing on Meadows Vale and respect the scale of surrounding buildings, particularly those in Meadows Vale. Landscaping should be used to minimise visual impact. Open space should create links to the surrounding countryside and the existing adopted core path east of the site.

**OP4:** Land at Chapelpark.

Allocation: 35 homes, including 8 affordable, and transport interchange

This site is a new allocation. In September 2016 the Council granted planning permission in principle for development of this site subject to the completion of a section 75 agreement. Development should minimise impact on two nearby listed buildings. Additional and/or improved pedestrian crossing facilities on the A947 may be required.


## **DAVIOT**


#### Vision

Daviot is an attractive village characterised by large areas of open community land set within rolling farmland on the edge of Daviot Estate. its historic assets, and the scenic views across the Formartine and Garioch countryside. The attractive setting of the village and its proximity to large service centres, means development pressure needs to be carefully managed to maintain the community land and setting of the village.

The planning objectives for Daviot are: protect the amenity of the village, meet local demand for homes, and support local services, including Daviot Primary School.

**Natural and Historic Environment:** The Loanhead stone circle and enclosed cremation cemetery is a scheduled monument just beyond the settlement's northern boundary.

#### Settlement Features

# **Allocated Sites**

OP1: Land to the south east

Allocation (Now completed): 8 homes, including 2 affordable

The site is a logical location for development, close to the village centre, a Primary School and several businesses, helping support these services. Closely defined boundaries will prevent overdevelopment which will be well screened by mature trees along its southern boundary. Site access should be from Wellbrae, to allow the strongest linkage to the village centre. Active travel links within the site are encouraged linking to both the village and the surrounding countryside. A footpath linking to the village and the Wellbrae core path will be required. Specific care is needed regarding visual impact of the development from the west. Landscaping should retain the remaining trees and woodland to screen the development from the south. Housing should be sympathetic to the character and setting of the site and to nearby housing.

# 3a: COMMUNITY ENGAGEMENT: MELDRUM FUTURE VISION.

Meldrum, Bourtie and Daviot Community Council established a sub-group, *Meldrum Future Vision*, to develop a Community Action Plan with support from the Formartine Partnership, Aberdeenshire Community Planning, and Community Learning and Development, to identify issues which needed addressing, to inform future development policies, particularly the 2021 LDP for Aberdeenshire. An online survey, supplemented by paper copies, was used to collect the data, and the *Place Standard* method was used to analyse it.

**PLACE STANDARD** is a new Scottish Government tool. It assesses places by their assets, strengths, and weaknesses to support the delivery of high-quality places in Scotland and to maximise the potential of the physical and social environment for health, wellbeing and a high quality of life.

### The STANDARD TOOL consists of:

14 THEMES relating to the physical and social elements of a place;

Each theme has a Key Question to be scored between 1 and 7;

(1 means a lot of room for improvement and 7 means very little)

Each Key Question has subsidiary "prompt" questions to help assess its score; and

Each Key Question has an "open comments box" to give reasons for the scoring.

The scoring allows instant comparison between settlements using a Compass Diagram.

The open comments boxes identify issues and inform interpretation of the Compass Diagram.

#### MELDRUM FUTURE VISION SURVEY

The group modified the place standard Survey to focus on Themes it felt were more relevant by

- Removing five themes: Streets & spaces, Natural space, Play & recreation, Identity & belonging, Care & maintenance;
- and adding two themes thought to be of particular interest:
  - ° Q2. Happiness: "In general, how happy are you living in your town or village?"
  - ° Q11. Health: "Are you satisfied with the local health and social care services and your ability to have your needs met when required?"
- Scoring the 55 prompt guestions, each with its open comments box;
- The open comments boxes generated 2675 comments to inform the interpretation.

This complicates comparisons with other settlements but improves ability to identify and address relevant local issues. Survey was open from 1st June to 30th September 2016: 525 people responded.

The weighted-average scores are plotted on the diagram. Those closer to the centre are most in need of improvement. Those towards the edge are strengths. The diagram shows, at a glance, in which themes a place performs well and where there is room for improvement. Meldrum's results, as a whole, are close to the centre, with few near the edge. There are no very high and no very low values. Only Traffic and Parking is below the weighted average halfway point 3.5 Feeling Safe is best. Happiness is third lowest.




Fig. 3.3. MELDRUM FUTURE VISION SURVEY: COMPASS DIAGRAM

#### DISCUSSION

Most comments relate to Happiness (383), dissatisfaction with existing facilities explains its low rating with 198 comments relating to shop provision. The survey coincided with campaigning to overturn a planning application refusal for a supermarket.

Traffic and Parking (291) had the second most comments, again of dissatisfaction relating to recent remodelling of the Square and perceived traffic, parking and safety problems.

Moving Around (280) would like to see more off-road footpaths and cycleways.

Public Transport service to Aberdeen was good but the service to Inverurie needed improvement

# MELDRUM FUTURE VISION: ENDORSEMENT of PRIORITIES:

Public Meeting on Saturday 27<sup>th</sup> May 2017

Meldrum *Future Vision* Committee analysed the survey results and identified issues for presentation at a Public Meeting on Saturday 27<sup>th</sup> May 2017 with more than 60 attending.

Each person was asked to place one coloured sticky dot beside each priority: green for support; yellow for neutrality and red for opposition. The scores are shown in the table below.

## 3b: COMMUNITY ENGAGEMENT: DAVIOT FUTURE VISION

#### DAVIOT FUTURE VISION PLACE STANDARD SURVEY – How Good is Our Place?

Daviot members of the Future Vision group carried out a separate survey of Daviot Village to test whether the issues would differ from Oldmeldrum. Thy used the same 11 Themes as the Meldrum Survey, but the Key Questions focussed specifically on Daviot. A paper copy of the survey was delivered to, and collected from, a total of 182 households throughout the village.

Open comment boxes, linked to two questions, allowed the underlying issues to be identified:

Q2: In general, how happy are you living in Daviot? the only rated question with an open-comments box

Q13: If you had one wish for Daviot what would it be? a purely open-comments question.

#### DAVIOT FUTURE VISION SURVEY: DESCRIPTION AND ANALYSIS

Seventy-five forms were returned and analysed, approximately 41% of households. Compared with Meldrum the Themes scored a higher average, 4.86, and a wider range, between 6.44 (*I feel safe*) and 2.96 (*Public transport*), the only Theme below the halfway point. The Compass Diagram is more variegated and less squashed into the centre.

The big difference was Happiness: this was ranked second not registering the dissatisfaction in the Meldrum survey relating to lack of shops and issues with the Square.

This is reinforced by the Open Comments on Q2, illustrating satisfaction with small village living, village facilities, fresh air, open countryside, rural walks and good accessibility: apart from public transport. The main concern was the threat of development as even a relatively small increase in houses would overwhelm the school and compromise safety on the narrow, mainly single-track, roads




Daviot Community Trust Walks Entrance

- Cycling connectivity in the village and to other communities. (look at the Borders)
- Path work in the Estate is excellent and appreciated.

# **PUBLIC TRANSPORT (9 Votes)** Inverurie satisfactory but poor frequency and lack of other destinations such as Oldmeldrum

- Public transport needs to be much better. If we were unable to drive, we would feel isolated here and our responses to this questionnaire would be much lower
- Public transport could be greatly improved especially at the weekend
- Better public transport; Better bus service;.... Public transport is poor access to facilities in Inverurie/Oldmeldrum only available by driving
- ..... Good bus service to Inverurie; Better public transport to Oldmeldrum as well as Inverurie......

- Nice, quiet place to live. Park and Stone Circle good for younger children
- Just moved to Daviot really enjoy the lovely walks. Would be good if there were more things for toddlers at the park and picnic benches

# THE FORMARTINE COMMUNITY PLAN (FCP) 2016-2019

The Formartine Community Plan 2016-2019 brings together input from a range of public services, Community Planning Partners, Elected Members and regular interaction with local communities. It identified four key priorities for Formartine:

# Fig. 4.1. FORMARTINE COMMUNITY PLAN 2016-19: Table of Priorities

## **Priority 1: STRONGER EMPOWERED COMMUNITIES**

- 1.1. Communities are empowered and supported to develop and deliver a vision for their local area
- 1.2. Communities are well informed, involved in decision-making and take a responsibility in delivery of local actions and priorities.
- 1.3. Stronger local resilient communities through the contribution of volunteers.

## **Priority 2: SAFER COMMUNITIES**

- 2.1. Fewer Formartine residents injured or killed as a result of preventable accidents, particularly in relation to road collisions, accidental dwelling fires and deliberate and non-domestic fires.
- 2.2. Formartine communities experience fewer instances of antisocial behaviour and residents experience a better quality of life, particularly in relation to vandalism and perceptions of safety.
- 2.3. Greater awareness of individuals, families and the vulnerable within our communities to be safe from harm (cyber safe) while online.

### **Priority 3: TACKLING INEQUALITIES**

- 3.1. Reduction in inequalities in health outcomes between identified communities in Aberdeenshire.
- 3.2. Equal access to early intervention and prevention creating healthier and active lifestyle choices, especially for older people and the vulnerable.
- 3.3. Enable individuals and families to make small changes that have long lasting positive impacts for themselves, their families and their community.
- 3.4. Children living in families who are vulnerable are identified and offered early support.

# **Priority 4: TRANSPORT AND CONNECTIVITY**

- 4.1. Demand responsive transport and supported bus network serving Formartine.
- 4.2. Improved transport to address healthcare and wellbeing, challenges of inequality, social exclusion, rural isolation and vulnerability.
- 4.3. Greater opportunity to encourage sustainable travel in the area for 30% of people covering shorter distances, to either walk or cycle all or part of their journeys.

# 5: PRIORITIES AND LINKS TO THE FORMARTINE COMMUNITY PLAN 2016-19: DISCUSSION

#### 5a: MELDRUM COMMUNITY ACTION PLAN

Moving Around: FCP Priorities: 1.1;1.2;1.3;2.1;2.2;3.1;3.2;3.3;4.3.

Strong support for cycleways and footpaths. Moving Around had the three highest ranked issues at the Endorsement meeting and the third highest number of open comments. There is a strong Paths group in Oldmeldrum.

# Walk/Cycle Path to Inverurie (57 votes)

Meldrum Paths group have a well-advanced project, to connect Oldmeldrum to Inverurie.

# Cycle/pathways around Oldmeldrum (52 votes)

Review needed of footpaths in Oldmeldrum, notably routes connecting new estates to the town centre.

# Walk/Cycle Paths to other communities (51 votes)

An obvious contender is a Meldrum Meg Way branch linking Daviot to Inverurie and Oldmeldrum

# **Community Action Plan**

# Traffic and Parking

Traffic and Parking had the second highest number of Open Comments and 4<sup>th</sup> and 5<sup>th</sup> ranked issues in the Endorsement meeting. They relate mainly to dissatisfaction with the recent remodelling of the Square and its perceived traffic, parking and safety problems.

Increase/improve town's pedestrian crossings (48 votes) FCP Priorities: 1.1; 1.2; 1.3; 2.1; 2.2; 3.1; 3.3.

There are no road signs or markings in the Square. Pedestrians are apprehensive about crossing the road, but the Square's small scale makes it difficult to meet criteria for more pedestrian crossings.

*Reduce Town centre parking congestion (44 votes)* 

FCP Priorities: 1.1; 1.2; 1.3; 2.1; 3.1; 3.3; 4.1.

The problem here is the small number of spaces in the centre and a tendency for commuters to occupy them all day. The proposed Transport exchange hub may alleviate this.

# **Public Transport**

*Improve Transport connection (48 Votes) 4.1; 4.2.* 

FCP Priorities: 1.1; 1.2; 1.3; 2.1; 2.2; 3.1; 3.2; 3.3;

Bus services are good to Aberdeen but much poorer to Ellon and Inverurie with its railway station.

# 5b: DAVIOT COMMUNITY ACTION PLAN

Moving around: footpaths and cycleways: FCP Priorities: 1.1; 1.2; 1.3; 2.1; 2.2; 3.1; 3.2; 3.3; 4.3.

The highest ranked issues cover appreciation of walks in and around Daviot and support for expansion to and within the Daviot Estate , improved continuous path to the Stone circle and cemetery. With support for safe, off-road access to Inverurie and Oldmeldrum, these form the highest priority.

A link to the proposed Meldrum Meg Way would connect Daviot to both.

**Opposition to Development** FCP Priorities: 1.1; 1.2; 1.3; 2.1; 2.2; 2.3; 3.2; 3.3.

The second ranked issue is local road capacity, village atmosphere and safety. There is strong opposition to housing development but some muted support for very limited small housing development.

**Playpark improvement** FCP priorities: 1.1; 1.2; 1.3; 2.2; 3.1; 3.2; 3.3; 3.4; 4.2.

There is also strong support for improving the playpark and a new group focussing on its improvement.

**B9001 Driving** FCP Priorities: 1.1; 1.2; 1.3; 2.1; 2.2; 3.1; 3.3.

Here are strong concerns about speeding/dangerous driving on the B9001 access to the village.

*Traffic Calming* FCP Priorities: 1.1; 1.2; 1.3; 2.1; 2.2; 3.3.

Traffic calming is contested and should not become an action until specific proposals can be clarified.

- ❖ A Park and Ride for commuters to Aberdeen is being delivered by Aberdeenshire Council\*
- ❖ More walking and cycle routes are in process of being provided by Meldrum Paths Group\*
- The Denwood walk has been vastly improved and now offers child friendly areas
- Bus services to Aberdeen have been cut but a new service to Inverurie and Daviot began in August 2019\*
- Bus waiting facilities and information panels have recently been renewed / updated in 2018\*
  MELDRUM FUTURE VISION PRIORITIES (Fig.3.6.)

Update: Local Development Plan 2017

❖ The LDP 2021 Main Issues Report is supporting increases in the LDP 2017 allocations:

**OP1 (FR119)**, Land North of Distillery Road, Oldmeldrum 99 homes. The capacity of this site has been increased from 50 to 99 homes to avoid underdevelopment.

**OP2 (FR068)** Coutens, Oldmeldrum 85 homes. The capacity of this site has been increased from 50 to 85 homes to avoid underdevelopment.

**OP4 (FR069)** Land at Chapel Park, Oldmeldrum 68 homes. The capacity of this site has been increased from 49 homes to 68 homes to avoid underdevelopment.

**FR061 Site 1**, Newbarns, Oldmeldrum 146 homes. The capacity of this site has been increased from 88 to 146 to avoid underdevelopment:

Increasing housing density may encourage the development of smaller, more affordable houses.

**OP3:** Land South of Millburn Road - 25 homes have been constructed by Aberdeenshire Council – these are now occupied as of July 2019

Update: MELDRUM FUTURE VISION PRIORITIES (Fig. 3.6)

Anti-social behavior and vandalism reports have improved

More facilities and amenities have been provided in the pleasure park area in 2017 - 2019

Health & Fitness activities have greatly improved with many different activities on offer

Doctors consulting hours altered to allow collection of medication prior to Pharmacy closing

More community activities are planned but improvement of communication of what activities are available has still to be addressed by Meldrum, Bourtie & Daviot Community Council.

# **Community Action Plan**

Update: MELDRUM FUTURE VISION OTHER DEVELOPMENTS

Prior notification for demolition of derelict property has been deemed unnecessary so can proceed War memorial lighting was installed in May 2019

Town Hall lighting was repaired and upgraded in August 2019

Meldrum Bourtie & Daviot Community Council will investigate potential space for a Community Facility LDP 2021 and planning lists are monitored as information is provided by Aberdeenshire Council

# **DAVIOT**

Daviot Community Trust has completed a paths network connecting the village and the new housing on Daviot Estate however connecting in Daviot requires improvement\*

Paths to the Cemetery were requested in June 2019 but rejected by Aberdeenshire Council due to lack of funding but however will be pursued by Meldrum Bourtie & Daviot Community Council\*

Fundraising for equipment for the pleasure park play equipment and football area is currently being undertaken by Daviot Amenities Improvement Group\*
